AND WHEREAS, Council deems it desirable to amend the "Quesnel 2016 - 2025 Tax Exempting Bylaw No. 1772 of 2015" by replacing the schedule;

NOW THEREFORE the Council of the City of Quesnel in open meeting assembled enacts as follows:

- 1. That the Quesnel 2016 2025 Tax Exempting Bylaw No. 1772 of 2015 be amended by replacing Schedule A with the attached Schedule A.
