TITLE: Assignment of Relocatable Classrooms DATE: March 24, 2022 PRESENTER(S): Timothy Rogers, Manager, School Planning Strategic Call To Action Alignment: This process supports the Strategic Call to Action (SCTA) by providing operations and practices that are responsive, transparent, fiscally responsible and accountable.

OVERVIEW: The Howard County Public School System uses relocatable classrooms to address crowding and programming needs. This report represents an evaluation by staff using considerations of capacity, projected enrollment, current number of relocatable classrooms and additional programs housed at each school. School Planning collaborated with School Facilities to determine the condition of current relocatables and School Construction to determine site accessibility and restraints. The relocation of three (3) single classroom units and a 5-classroom unit is recommended by staff. Specific recommendations and supporting data are included as attachments to this report.

Recommendation of Relocatable Classroom Placement for SY 2022-2023 Summary

Staff Installation Recommendations and Justifications:

The primary criterion for recommending installation of a relocatable classroom is to provide immediate relief from high capacity utilization. Projected capacity utilization percentages for SY 2022–2023 are based on the recent enrollment projections and approved capacities. Other factors considered include classroom needs for programmatic initiatives, Title I, as well as school layout, room size and availability for pull-out services.

While K-12 enrollment decreased slightly this year, mainly due to the impacts of the COVID-19 pandemic on school choices, it is anticipated that student enrollment will increase for SY 2022-23. At this time, many signs point to a return to pre-pandemic conditions in the near-term. However, it is unclear how factors that influence student enrollment will change in the coming years. Capital funding for new schools and renovations/additions is not expected to increase in a way that allows HCPSS to build new square footage in brick and mortar in order to keep up with projected growth. School boundaries have been adjusted to better use existing capacity; however some schools are projected to need additional space based on enrollment, special programs, additional staffing for Title I, small classroom sizes, minimal pull-out spaces, etc. Relocatable classroom placement can be used as a temporary tool to provide flexibility for space needs at schools.

The current Board of Education Capital Budget request for relocatable placement is \$2 million. The below recommendation is a collaboration between School Planning, School Facilities (to determine the condition of current relocatables) and School Construction (to determine site accessibility and restraints). This year's recommendations are to relocate units currently located at schools under construction, to schools identified as having capacity concerns due to enrollment and program expansion. Staff has visited and discussed concerns and relocatable classroom options with school administrators and Community Superintendents. Discussions included academic programming, student enrollment projections, space usage, space (re)allocation, and scheduling.

This recommendation takes into account factors known at this time and does not account for potential impacts of recent Board requests to reduce class sizes and eliminate "sprinkling" for related arts classes. These initiatives, first proposed in the Board Requested FY 23 Operating Budget, will require additional planning if funded in the final budget.

Justification: The 5-classroom modular from Talbott Springs ES needs to be removed and the Bollman Bridge ES site is capable of accepting the large relocatable. This placement can provide additional space to the school so early childhood and special education programs can be expanded in the school facility.

Justification: West Friendship ES is experiencing space shortages for their instrumental music program and requested a relocatable classroom. Projections indicate the enrollment at this school will continue to increase through 2026.

ATTACHMENT 3

Under *consideration* for future placement (school year 2023–2024 and beyond)

Overview: A survey was sent to school principals to gauge their space needs. Fifteen principals requested one or more relocatable units be placed at their schools over the summer of 2022. Not all requests for relocatables can be honored. Budgetary constraints limit the number of units that can be placed. Below is a list of schools that are under consideration for potential placement of relocatables in SY 2023–2024 (or later). Upon receipt of additional funding next year and after the Board's approval of boundary line changes, staff will update and narrow the list of needs next year.
