

**Express Assumption of Risk & Release of Liability  
COVID-19 & Other Infectious and/or Communicable Diseases**

This Express Assumption of Risk & Release of Liability applies to attendance at the \_\_\_\_\_

This is an acknowledgement and express assumption of risk and release of liability as it relates to the risks of being exposed to or contracting COVID-19 (as defined by the World Health Organization and any strains, variants, or mutations thereof), the coronavirus that causes COVID-19, or any other communicable and/or infectious disease (collectively “COVID-19”), while visiting DePaul’s premises. You expressly understand that these risks include contracting COVID-19, the associated dangers, medical complications and physical and mental injuries, both foreseen and unforeseen, that may result from contracting COVID-19 during your visit.

You further acknowledge and understand that any interaction with the general public poses an elevated, inherent risk of being exposed to and contracting COVID-19, that DePaul cannot guarantee that you will not be exposed during your visit, and that as such, potential exposure to or contraction of COVID-19 is a risk inherent in your decision to visit DePaul and cannot be eliminated. You further acknowledge and understand that if infected with COVID-19, you may infect others you subsequently come into contact with, even if you are not experiencing or displaying any symptoms of illness yourself, and that the risk of spreading COVID-19 to others remains after you depart DePaul’s premises.

YOU, ON BEHALF OF YOURSELF AND YOUR PERSONAL REPRESENTATIVES, HEIRS, EXECUTORS, ADMINISTRATORS, SUCCESSORS AND ASSIGNS HEREBY RELEASE, DISCHARGE AND HOLD HARMLESS DEPAUL, ITS TRUSTEES, OFFICERS, FACULTY, EMPLOYEES, AGENTS, SUCCESSORS AND REPRESENTATIVES WITH RESPECT TO ANY CLAIM, LIABILITY, SUIT, LOSS AND COST OF WHATEVER KIND OR NATURE, EITHER IN LAW OR IN EQUITY AND FOR NEGLIGENCE (INCLUDING, WITHOUT LIMITATION, FOR PERSONAL INJURIES OR WRONGFUL DEATH) THAT MAY ARISE IN CONNECTION WITH, OR RELATE IN ANY WAY TO, EXPOSURE TO OR CONTRACTION OF COVID-19 DURING YOUR VISIT TO DEPAUL’S PREMISES. YOU FURTHER AGREE THAT THE FOREGOING RELEASE OF LIABILITY AND HOLD HARMLESS AGREEMENT EXTENDS TO AND ENCOMPASSES ANY CLAIM, LIABILITY, SUIT, LOSS AND COST OF WHATEVER KIND OR NATURE THAT RELATES IN ANY WAY TO EXPOSURE TO OR CONTRACTION OF COVID-19 BY ANY OTHER INDIVIDUAL, INCLUDING BUT NOT LIMITED TO YOUR COHABITANTS AND/OR FAMILY MEMBERS, AS A RESULT OF THEM BEING EXPOSED TO SUCH DISEASES BY YOU AFTER YOUR VISIT TO DEPAUL’S PREMISES.

You further agree that on each day of the event prior to your attendance, you shall conduct a self-screening process using the #CampusClear app ([Health Monitoring Resources](#)) and, if you exhibit any symptoms related to COVID-19, you will not enter DePaul’s premises.
