

## 2022 Income and Resource Limits for Medicaid and Other Health Programs

Public benefit programs (such as Medicaid) use the Federal Poverty Level (FPL) guidelines to determine who qualifies for coverage. The table below includes the current income and resource limits someone needs to meet to qualify for Medicaid, CHIP, and Part D Extra Help this year. The income limits are based on the 2022 FPL guidelines that were published in January.

Please see our <u>Medical Assistance Eligibility Manual</u> for further explanation of what income and whose income counts towards the limits listed below.

Workers with Job Success (WJS)*	For people on MAWD for 12 consecutive months and who still qualify but for income.	\$6,795 single \$9,155 married	Same as above**
Home and Community-Based Services (HCBS) Waivers	Individuals age 60 and older and younger people with certain disabilities can get support services to remain living as independently as possible and get full Medicaid coverage. Must meet level of care <b>and</b> financial requirements.	\$2,523 (only applicant's income is counted)	\$8,000 (if married, the resources of both spouses are considered and spousal impoverishment rules apply)
Medicaid for Children and Pregnant Women	Full Medicaid coverage is available to children from birth through age 18 and Pregnant Women The pregnant woman counts as 2 people or more depending on how many babies she is expecting.	Pregnant Women and children < 1: \$3,357 (HH size 2) \$4,223 (HH size 3) \$5,088 (HH size 4)	Resources not counted

Children's Health Insurance Program (CHIP)	Children who are not eligible for Medicaid and who do not have any other insurance can qualify for CHIP.	Free CHIP: \$3,251 (HH size 2) \$4,088 (HH size 3) \$4,926 (HH size 4)	Resources not counted
