AN ACT

- 1 Providing for expedited partner therapy and for liability.
- 2 The General Assembly of the Commonwealth of Pennsylvania
- 3 hereby enacts as follows:
- 4 Section 1. Short title.
- 5 This act shall be known and may be cited as the Expedited
- 6 Partner Therapy Act.
- 7 Section 2. Definitions.
- 8 The following words and phrases when used in this act shall
- 9 have the meanings given to them in this section unless the
- 10 context clearly indicates otherwise:
- "Health care practitioner." As defined in section 103 of the
- 12 act of July 19, 1979 (P.L.130, No.48), known as the Health Care
- 13 Facilities Act.
- 14 "Pharmacist." As defined in section 2(10) of the act of
- 15 September 27, 1961 (P.L.1700, No.699), known as the Pharmacy
- 16 Act.

- 1 "Pharmacy." As defined in section 2(12) of the Pharmacy Act.
- 2 Section 3. Health care practitioners.
- 3 (a) General rule. -- Notwithstanding any other provision of
- 4 law or regulation, a health care practitioner may issue a
- 5 prescription for or personally furnish antibiotics to treat
- 6 sexually transmitted infections, without having examined the
- 7 individual for whom the drug is intended, in accordance with the
- 8 Expedited Partner Therapy in the Management of Sexually
- 9 Transmitted Diseases guidance document issued by the United
- 10 States Centers for Disease Control and Prevention, if:
- 11 (1) The individual is a sexual partner of the health
- 12 care practitioner's patient.
- 13 (2) The patient has been diagnosed with a sexually
- 14 transmitted infection.
- 15 (3) The patient reports to the health care practitioner
- that the individual is unable or unlikely to be evaluated or
- 17 treated by a health professional.
- 18 (b) Name on prescription. -- If the health care practitioner
- 19 is unable to obtain the individual's name, the prescription
- 20 shall include the words "expedited partner therapy" or the
- 21 letters "EPT."
- 22 (c) Prescribed drug. -- For each drug prescribed, the health
- 23 care practitioner shall do all of the following:
- 24 (1) Recommend to the patient that the individual seek
- treatment from a health professional.
- 26 (2) Document the name of the drug prescribed and its
- dosage in the patient's record.
- 28 (d) Furnished drug. -- For each drug personally furnished, the
- 29 health care practitioner shall do all of the following:
- 30 (1) Provide the patient with information concerning the

- drug for the purpose of sharing the information with the
- 2 individual, including directions for use of the drug and any
- 3 side effects, adverse reactions or known contraindications
- 4 associated with the drug.
- 5 (2) Recommend to the patient that the individual seek 6 treatment from a health professional.
- 7 (3) Document all of the following in the patient's
- 8 record:

- (i) The name of the drug furnished and its dosage.
- 10 (ii) That information concerning the drug was
- provided to the patient for the purpose of sharing the
- information with the individual.
- 13 (e) Contact permitted. -- A health care practitioner who
- 14 prescribes or personally furnishes a drug may contact the
- 15 individual for whom the drug is intended.
- 16 (f) Liability for prescribing or furnishing drug. -- A health
- 17 care practitioner who in good faith prescribes or personally
- 18 furnishes a drug is not liable for or subject to any of the
- 19 following:
- 20 (1) Damages in a civil action.
- 21 (2) Prosecution in a criminal proceeding.
- 22 (3) Professional disciplinary action.
- 23 (g) Liability for not prescribing or furnishing drug.--A
- 24 health care practitioner shall not be subject to civil, criminal
- 25 or professional liability for choosing not to provide expedited
- 26 partner therapy.
- 27 Section 4. Pharmacists.
- 28 (a) Dispensing and labeling drug. -- Notwithstanding any other
- 29 provision of law or regulation, a pharmacist may:
- 30 (1) Dispense a drug pursuant to a prescription issued

- 1 under section 3(a).
- 2 (2) Label a drug dispensed pursuant to the prescription
- 3 without the name of the individual for whom the drug is
- 4 intended if the prescription contains the words "expedited
- 5 partner therapy" or the letters "EPT."
- 6 (b) Information required when dispensing drug. -- For each
- 7 drug dispensed, the pharmacist shall provide all of the
- 8 following information:
- 9 (1) Directions for use of the drug.
- 10 (2) Any side effects, adverse reactions or known
- 11 contraindications associated with the drug.
- 12 (c) Liability for dispensing drug. -- A pharmacist or pharmacy
- 13 that in good faith dispenses a drug pursuant to a prescription
- 14 issued under section 3(a) for expedited partner therapy is not
- 15 liable for or subject to any of the following:
- 16 (1) Damages in a civil action.
- 17 (2) Prosecution in a criminal proceeding.
- 18 (3) Professional disciplinary action.
- 19 (d) Distribution of information. -- This section does not
- 20 affect the authority of a pharmacist to distribute information
- 21 concerning a drug as required by Federal law.
- 22 Section 5. Effective date.
- 23 This act shall take effect in 90 days.
