1. Climate Resilience Design Standards and Guidelines Overview

1.1. Resilient Massachusetts Action Team (RMAT) Background and Context

Led by the Executive Office of Energy and Environmental Affairs (EEA) and the Massachusetts Emergency Management Agency (MEMA), the Resilient Massachusetts Action Team (RMAT) is an inter-agency team comprised of representatives from each Secretariat, who are supported by agency staff, stakeholders, and subject matter experts. The RMAT is tasked with monitoring and tracking the State Hazard Mitigation and Climate Adaptation Plan (SHMCAP) implementation process, making recommendations and supporting agencies on plan updates, and facilitating coordination across State government and with stakeholders, including businesses, cities, and towns.

The RMAT is advancing prioritized cross-agency actions from the SHMCAP with the Climate Resilience Design Standards and Guidelines project. The Climate Resilience Design Standards and Guidelines are intended to help incorporate climate resilience into capital planning projects with physical assets owned and maintained by state agencies, through:

- Beta Climate Resilience Design Standards Tool: a beta web-tool for agencies that provides a preliminary climate risk screening output and recommended climate resilience design standards for State projects with physical assets; and
- **Climate Resilience Design Guidelines**: guidelines, best practices, and forms for State agencies to support implementation of climate resilience design standards.

1.2. How to Use this Document

This User Guide ("the Guide") walks users through the beta Climate Resilience Design Standards Tool ("the beta Tool"). Visuals and screenshots are used to show standard views, key features and functions, and text descriptions provide overviews of actions at each step in the process.

2. Beta Climate Resilience Design Standards Tool

2.1. Introduction to the beta Tool

Purpose

The purpose of the beta Tool is to provide projects with a preliminary climate exposure and risk rating and to support the integration of climate resilience design standards and guidelines into state funded projects with physical assets. The web-based screening tool is grounded in scientific methodology and uses available climate science data for Massachusetts, and will be updated over time to incorporate new science, additional or evolving climate parameters, and on-going stakeholder feedback.

The beta Tool is intended for relevant state grant-funded projects throughout the Commonwealth and capital projects by various State agencies. The beta Tool does not take the place of statutory regulations or requirements, and does not replace detailed risk and vulnerability assessments, engineering alternatives analyses, or cost-benefit analyses. User Roles

There are three primary users. Each type of user has different capabilities and roles within the beta Tool, as described below.

• **Reporter:** Can create new projects, edit, and view their own projects. This is the default user type.

For example, this user may be a municipal staff member submitting a project as part of a state grant application.

• Viewer: Can view all saved and submitted projects, including inputs and outputs.

For example, this user may be a State grant administrator.

• Administrator: Can view and edit all projects in the beta Tool. Administrators are limited to select EEA IT staff. For example, this user may be an Agency Administrator or IT staff. This Guide provides stepby-step guidance for the 'Reporter' user role, unless otherwise noted.

2.2. Key Tool Components

The beta Tool has five main components: Map View, Project Inputs; Project Outputs; Additional Documents and Resources; and Report Preview. Information provided by users via the Map View and Project Inputs generate Project Outputs. Additional Documents and Resources include the supplementary *Climate Resilience Design Guidelines* and best practices and optional Forms that provide design and implementation considerations informed by Project Inputs and Outputs. This component further includes key resources, such as the *Glossary of Terminology* and documents describing beta Tool methodology. The fifth component includes a Project Report specific to a user's individual project, summarizing inputs and outputs from the beta Tool.

The beta Tool process is captured in Figure 1, under User Guide sub-section 2.3. The documentation detailing the beta Tool methodology can be found under the Additional Documents and Resources tab.

Map View (1st tab in the beta Tool)

The beta Tool's Map View component allows users to view and draw the location of their project by creating a GIS-based polygon. The display and functionality are described further in Section 3.2 of this User Guide.

Project Inputs (2nd tab in the beta Tool)

The beta Tool prompts the user to input additional details related to the project's location, and the project's physical asset(s)¹ ("Project Inputs"). The inputs are structured by two components: (1) questions regarding overall project details and its climate exposure, and (2) questions related to individual physical asset(s) within the overall project. These inputs are captured through drop-down menu responses and select automated spatial queries.

¹ In the beta Tool, an Asset is defined as a major physical component of a project. It is further organized by an Asset Category: building/facility, infrastructure, or natural resources.

The display and functionality are described further in Section 3.2 of this User Guide. For additional documentation of the Project Inputs, refer to **Section 2: Project Inputs and Climate Risk Screening Output**, available under the Additional Documents and Resources tab.

Project Outputs (3rd tab in the beta Tool)

The beta Tool has two main outputs: the Climate Risk Screening Output and the Recommended Climate Resilience Design Standards Output.

The Climate Risk Screening Output is intended to support project development and capital planning. This is a preliminary screening output, and does not replace a formal risk and vulnerability assessment. The Climate Risk Screening Output includes:

- a **preliminary exposure rating** for the overall project for each climate parameter: sealevel rise/ storm surge, extreme precipitation (urban and riverine), and extreme heat;
- a **preliminary risk rating** for each building and infrastructure asset within the overall project for each climate parameter: sea-level rise/ storm surge, extreme precipitation (urban and riverine), and extreme heat; and
- an ecosystem services benefits score for the overall project.

The main objective of the Recommended Climate Resilience Design Standards Output ("the Standards") is to provide a consistent basis-of-design for assets across various projects in the Commonwealth related to the following climate parameters: sea level rise and storm surge, extreme precipitation, and extreme heat. The Standards for each asset include the following:

- **planning horizons** for each asset, inclusive of a target and intermediate planning horizon for sea level rise/ storm surge, and a target planning horizon for extreme precipitation and extreme heat;
- a return period for building and infrastructure assets, for the sea level rise/ storm surge and extreme precipitation climate parameters, and a percentile² for each asset, for the extreme heat climate parameter;
- **applicable design criteria** for each asset and climate parameter, based on asset type and project location; and
- **tiered methodology** based on the recommended level of effort that informs users on how to calculate design criteria values for asset and project design.

² Percentile: For the extreme heat climate parameter, the Tool will provide a recommended percentile for each asset (10th, 50th, or 90th percentile), as opposed to a recommended return period. While an asset's useful life does inform the recommended return period output for the sea level rise/ storm surge and extreme precipitation climate parameters, it does not inform the recommended percentile output for the extreme heat climate parameter. This difference is recommended since impacts from flooding are episodic, whereas impacts from heat are likely to be experienced by an asset regularly over its useful life and cannot be typically assigned a frequency of occurrence. The percentiles for design recommended by the Tool are also dependent on asset construction type, instead of asset type as for the sea level rise/ storm surge and extreme precipitation climate parameters. This difference is due to the difficulty in accommodating for extreme heat resilience in existing construction design.

Report Preview (4th tab in the beta Tool)

The beta Tool further provides users with the opporutnity to review and download their Project Report in the Report Preview tab. Here, users may view a summary of the project and asset outputs, informed by project inputs.

Additional Documents and Resources (5th tab in the beta Tool)

The beta Tool also provides Climate Resilience Design Guidelines ("the Guidelines") and Best Practices, Forms, and other supporting documents.

- The Guidelines are intended to be overarching climate resilience principles that are not specific to project/asset type or climate parameters. The Guidelines provide general design guidance for users to consider while implementing the Standards. These Guidelines are illustrated through specific best practices, which will include case studies and/or existing published resources that exemplify the Guidelines.
- A series of optional **Forms** walk users through Guidelines considerations and serve to document design and decision making throughout the process. These forms include the following:
 - Site Suitability Form
 - Regional Coordination Form
 - Flexible Adaptation Pathways Form
- Other supporting documents provided by the beta Tool include the *Glossary of Terminology* (for industry and beta Tool-specific definitions), *Responses to Questions Received During Stakeholder Outreach*, and section documentation (outlining beta Tool methodology), as follows:
 - Section 1: Project Overview
 - Section 2: Project Inputs and Climate Risk Screening Output
 - Section 3: Climate Resilience Design Standards Overview

2.3. Climate Resilience Design Standards and Guidelines Process

The overall process for the Climate Resilience Design Standards and Guidelines is shown in Figure 1, below, including the beta Tool. The beta Tool includes a Map View as part of the Project Inputs that enables users to draw the location of their project site as a polygon.

3. Beta Tool Functionality and Features

3.1. General Functionality

The beta Climate Resilience Design Standards Tool and Guidelines are **accessible at ResilientMA.org**, and are relevant to state grant-funded projects throughout the Commonwealth and capital projects by various State agencies.

Login

Navigate to the beta Tool link, provided above, to begin login. Here, users can create an account, retrieve a password, activate a user, and update a user profile. The dashboard outlook for this login page is shown in Figure 2, below.

Project Tabs

There are five main navigation tabs in the beta Tool: Map View, Project Inputs, Project Outputs, Additional Documents and Resources, and Report Preview. These tabs can be found on the left side of the display, across the top.

The remainder of this User Guide will proceed along the beta Tool process, moving through each tab view and it's associated functionality.

3.2. Tab: Map View

In this display, users can search for an existing project, create a new project, and change base map layers. This display is useful in viewing the location of existing projects, whether still being edited or already submitted. The Map View page is shown in Figure 3, below.

Search

To search for an existing project that has already been created, locate the "Project Search" box on the left side of the screen under "Project Name" and proceed with entering a search word for the project name. Reporters may only search and view results for projects they have created, while Viewers and Administrators can search and view all projects. Results will begin populating with relevant projects, previously saved. Select the "Filter Projects" button once complete. Refer to Figure 4, below.

New Project

To create a new project within the beta Tool, select the "New Project" button. Enter a name for the new project. Click the green "Save" button to continue. If additional changes are necessary, click "Cancel". Refer to Figures 5 and 6 for a review of this process, below.

Draw a Project Polygon

This step involves drawing the location of the new project on the map. It is the first step to begin establishing Project Inputs in the beta Tool. This project polygon will be used to determine project exposure to climate parameters, hence it is important the polygon encompasses all (on-site) physical assets of the project.

Follow the instructions on the screen to draw the project polygon, as shown in Figure 7. Select the "Polygon" button shown in Figure XX, located in the top right corner of the map, to begin drawing the project polygon. The drawn polygon is now a feature. Refer to Figures 7 through 9, below.

Tip: Watch the how-to video! Avoid confusion by clicking on the "Show me how" button (shown in Figure 7) to watch a short video on how to draw the project polygon.

Tip: Avoid bad polygons! Avoid creating polygons that loop back onto themselves. This generates separate and distinct polygons. If this is accidently generated, please "Delete" the polygons and redraw.

Save or Cancel the Project Polygon

Once the drawn polygon is complete, users can "Save" or "Cancel" their drawing using the buttons shown in Figure 10, below. Note that on this display, users can "Find address or place" to search the map, use the arrow pointer to select polygon objects, or "Undo" and "Redo" actions. **Users should further be aware that they will not receive project outputs unless their project polygon has been saved.** Also, once saved, any edits to the project polygon will result in rescoring of the project outputs.

Edit the Project Polygon

To edit the project polygon once it has been saved, click on the project name in the Project panel on the left side of the screen. Viewing the project, select "Edit." The project polygon can now be moved and resized, as shown in Figure 11. Double-click on the polygon feature already formed to edit the polygon's vertices. "Delete" pologyons using the trash icon (above the "Save" button at the top right corner).



Tip: Don't forget to Save any changes made in Edit mode!

Viewing a Project Polygon

When returning to an existing project highlighted under "Results", selecting a project in the left projects panel will automatically zoom to the project polygon, as shown in Figure 12, below.

3.3. Tab: Project Inputs

Once the user has completed drawing and editing the project polygon, they move to the "Project Inputs" view, shown in Figure 13. This tab, to the right of the "Map View" tab, directs the user through inputting required information. The beta Tool prompts the user to input details related to the overall project and the project's physical asset(s).

This tab is broken down into four different steps to provide required information for output generation:

- Step 1: Core Project Information
- Step 2: Project Ecoystem Services Benefit
- Step 3: Project Climate Exposure
- Step 4: Project Asset(s)

Each "Step" is a series of questions to select or toggle for responses. The beta Tool then uses these inputs, including the project polygon drawn by the user, to generate the Project Outputs.

Tip: There's more on Project Inputs! Refer to Section 2: Project Inputs and Climate Risk Screening Output, available under the Additional Documents and Resources tab, to learn more about Project Inputs and how they were established.

Step 1: Core Project Information

The first set of inputs required for a project consists of the core project information. To complete these questions, click on the question or the space next to the question, and either a drop-down, fill-in-the-black, or pre-populated answer choice will appear. After selecting or responding, click the "Save" button for each question to lock in the answer. Answers can be modified and resaved as needed using the "Save" button. The Steps to complete this process are illustrated in Figures 14 through 16, below.

Tip: Don't forget to Save after each question! Don't forget this step--all questions are required. Unanswered questions will appear in red, while completed saved responses will appear in black.

Certain questions, as indicated, may display an information icon **1** for further details or definitions. Clicking on the icon will reveal this information. An example is shown below in Figure 17.

Step 2: Project Ecosystem Benefits

In order to provide a preliminary assessment of the ecosystem services that an overall project provides, a series of project ecosystem benefits questions must be completed, as shown in Figure 18. Repsonses to these questions come in a Yes/No toggle, and definitions are provided through the information icon () on the left side of the question. Note: The ecosystem service should be answered by considering the overall project, not specific to an asset.

Step 3: Project Exposure Questions

In order to provide a preliminary assessment of a project's exposure to climate parameters (sea level rise/ storm surge, extreme precipitation, and extreme heat), users must answer questions regarding the history of on-site flooding, impervious areas, and trees. Additional information icons are available to assist users in answering the project exposure questions. Additional details about a project's exposure to climate parameters are assessed geospatially by the beta Tool, based on project polygon location, as drawn by the user. The sequence of steps and example expanded information are shown below in Figures 19 through 21.

Step 4: Project Assets

An asset is defined as a major physical component of a project, organized into an Asset Category: building/facility, infrastructure, or natural resources. In this section, users are prompted to identify all major physical assets present in the project, and answer questions related to each asset. To add an asset, the user should select the "Add" button under the three main Asset Categories, as shown in Figure 22. The user may add multiple assets under each Asset Category, as necessary. For example, a park improvement project may include assets such as a berm for a flood control structure as an *infrastructure* asset, a living shoreline as a *natural resources* asset, and a park facility as a *building/facility* asset.

Upon selecting the "Add" button, the user must fill out asset information to "Create Asset". Asset Type, Sub-Type, and Construction Type are all drop-down boxes, for users to select based on what is most representative of the individual asset. **Construction Year refers to the year in which construction is expected to start on the asset. Useful Life refers to the estimated number of years before the project will require significant reconstruction or renovation to continue performing its normal function(s).** This differs from the design life, which is typically shorter. Once the information is inputted, click the "Create" buton to save that asset. If further changes are necessary, click "Cancel". This process is illustrated in Figures 23 and 24, below.

Tip: Finalize asset details before selecting Create! Once the Create button is selected, only the Construction Type, Construction Year, and Useful Life can be modified.

Once a building/facility and/or infrastructure asset is added, the user must answer questions to inform the asset's preliminary risk screening and standards outputs. To answer a question, click on the question itself, as shown in Figure 26. All questions should be completed within the context of the selected answer for the first question, "Identify the length of time the asset can be inaccessible/inoperable without severe consequences."

Note: Natural resources assets will not be prompted to answer these questions.

3.4. Tab: Project Outputs

Upon completion of the Project Inputs, the user may then navigate to the "Project Outputs" tab, shown in Figure 30, below. Here, the user can view the selected project's and asset's Climate Exposure and Risk Screening Output and Recommended Climate Resilience Design Standards Output. The Ecosystem Benefits Score and Exposure Scores are assigned to the overall project, while the Risk Scores and Standards are asset-specific.

Ecosystem Service Benefits Score and Preliminary Climate Exposure Ratings are available for each project, under "Project Scores" (below the first light blue banner). Projects with multiple assets will show different Standards for *each* asset, under "Asset Preliminary Climate Risk Rating and Recommended Standards" (below the second light blue banner). Users can navigate between assets by selecting the assets on the left side of the screen, under "Project Assets" (below the second light blue banner). This is illustrated in Figure 30 and 31, below.

Ecosystem Service Benefits Score

The purpose of this output is to provide an overall indication of the ecosystem service benefits (ESB) provided by a project, through protection of natural resources and implementation of nature-based solutions. Low ESB scores, as shown in Figure 32, indicate projects do not provide substantial benefits to ecosystem services and suggests that nature-based solutions are not part of project design. High ESB scores indicate that projects significantly benefit ecosystems and suggests nature based solutions are a central part of the overall project. Users are encouraged to identify how their project may provide or protect ecosystem services in design to increase this score. Additional guidance is available in the **Section 3: Climate Resilience Design Standards Overview** documentation, under the Additional Documents and Resources tab.

Preliminary Climate Exposure Rating

The purpose of this output is to provide a preliminary assessment of whether the project site and subsequent assets are exposed to impacts of natural hazard events and/or future impacts of climate change.

Preliminary Climate Exposure Ratings are calculated based on submitted Project Inputs—the project location polygon and user question responses, analyzed for each climate parameter: sea level rise and storm surge, extreme precipitation (urban and riverine), and extreme heat.

For each climate parameter, the beta Tool will calculate one of the following exposure ratings: Not Exposed, Low Exposure, Moderate Exposure, or High Exposure. An example of this output for a project is shown in Figure 33. Note: The exposure is not based on individual asset locations—only the overall project location. The exposure rating does not substitute a formal vulnerability assessment.

For project locations exposed to sea level rise and storm surge, the user will receive the first Planning Horizon in which the site is exposed to coastal flooding for the 100-year or 1% annual exceedance probability (AEP) flood event. This can be viewed in the expanded dashboard, found by selecting the region in the expanded dashboard.

Users may view additional information about why the project received each exposure rating upon selection of the *icon*. These descriptions vary for each climate parameter and are based on resulting Project Inputs and GIS-based analysis within the beta Tool.

Preliminary Climate Risk Rating

The purpose of this output is to provide an initial screening to identify projects and assets with a High Risk designation, which may warrant additional review and/or design considerations.

A Preliminary Risk Rating is determined for each applicable climate parameter, and for building, and infrastructure assets, based on the Preliminary Exposure Rating and responses to questions provided by the user. An example output for each climate parameter is shown in Figure 35, with the expanded dashboard output providing further detail on the inputs informing the high risk output shown in Figure 36. Note: Natural resources assets will not receive a Preliminary Risk Rating output as part of the Climate Risk Screening Output, as natural resources were exempt from risk ratings as part of the methodology.

The applicable design critieria are based on Asset Type and Project Location, informed by GIS-based exposure to sea level rise / storm surge. Users may download the tiered methodology documents via the download button in the bottom right corner.

Certain sea level rise/storm surge design criteria (Tidal Benchmarks; Stillwater Elevation; Design Flood Elevation, Wave Heights) are standards outputs from the Massachusetts Coast Flood Risk Model (MC-FRM) and these recommended values are anticipated to be available directly in the beta Tool in a forthcoming update Summer 2021. The applicable design critieria are based on Asset Type and Project Location, informed by GIS-based exposure to extreme precipitation for riverine and urban flooding. Users may download the tiered methodology documents via the download button in the bottom right corner.

3.5. Tab: Report Preview

Upon review of the Project Outputs, users may proceed to viewing and downloading their Project Report under the Report Preview tab. Here, the Project Inputs and Outputs have been summarized in report format and are available for download. The Project Report can then be printed for inclusion with grant submissions. An example of this tab can be previewed in Figure 42, below.

Users should click the button "Generate Report" to generate the report for their project. Once users have generated a report, users will be able to click the button "Download Report" to download the report. A PDF of the report will then download to the download folder of the web browser.

The Additional Documents and Resources are composed of four downloadable documents: one for all of the Guidelines and Best Practices, and one for each of the three recommended Forms.

Guidelines

Supplemental resources that provide principles and best practices for implementing the Standards. The Guidelines constitute design principles related to site suitability, flexible adaptation strategies and regional coordination that are illustrated through forms and specific "best practices," which may include case studies and/or existing published resources that exemplify the Guidelines.

Site Suitability Form

Optional form aimed at evaluating how geographic location, existing conditions, and asset placement impact the sites' ability to serve its intended function, before, during, and after climate impacts.

Regional Coordination Form

Optional form aimed at guiding considerations of how coordination and collaboration across regions, as well as State Agencies and jurisdictions, can help strengthen resilient designs and implementation.

Flexible Adaptation Pathways Form

Optional form aimed at evaluating project design strategies that are able to adapt over time and respond to changing climate conditions, while encouraging climate mitigation, prioritizing naturebased solutions, and preparing for current and future operations and maintenance needs.
