There is a CPF report from me with details on the broad collaboration and support during the CPF event. See links on Larimer Assessor's multiple press releases on jurisdictional collaboration to assist each other when a disaster impacts communities, 2020 CPF report, tax credits to impacted residents and the 2021 International Association of Assessing Officers' invitation and education to a global audience of professionals on best practices and lessons learned from CPF fire and recovery efforts.
