#### **Age Classifications:**

### **Bow Classifications**

**Recurve:** Bows may be equipped with a single sighting device, single pin, multiple pin, or hunting style sights; may not be equipped with string peeps or string marks for rear sights.

**Compound UnAided:** Bows may not be equipped with magnified sights or stabilizers. Bows may be equipped with single pin or multiple pin sights. Mechanical release aids are not permitted. This class includes all Genesis/NASP bows.

**Compound Aided:** Bows may be equipped with magnified sights and stabilizers.

**Barebow:** Bows may not be equipped with any sights or stabilizers. No mechanical releases aids are permitted.

#### **Awards**

Youth: 1st-3rd place awarded for each age division and classification.

Buckles will be awarded for 1st place (mailed to you after the competition)

**Adults:** 1st-3rd awarded for each classification 50% payback of entry fee (out of payback, 50% to 1st, 30% to 2nd, 20% to 3rd)
