



2nd Quarter 2021 Nonresidential Development and Overall Development Values Shatter Five Year Highs


- The permitted nonresidential construction value for the 2nd quarter of 2021 (\$267 million) eclipsed the previous five-year high (set in 2019) by \$139 million.
- Nonresidential redevelopment square footage permitted in the 2nd quarter of 2021 (3.2 million) exceeded the previous five-year high by more than 1 million square feet.
- The total permitted construction value (\$395 million) for the quarter bested the previous 2nd quarter record by \$169 million and exceeded the total permit value for all of calendar year 2014.






